How to fill out your pledge card

STEP 1: Select payment method. Indicate your method of payment by selecting check, cash, or direct bill.

STEP 2: Indicate Recognition Method. If a leadership giver (\$500.00 or more), indicate how you would like to be recognized. If not, proceed to Step 3.

STEP 3: Agency Designation - visit ufcc.ufl.edu for agency information

If designating to a specific agency, select your agency's code below. Enter the amount you would like to designate. Undesignated contributions, including any non-renewed, prior-year designations will be divided proportionally to each agency according to the percent each agency receives in designated funds. United Way of North Central Florida will receive the undesignated dollars awarded to the United Way Agencies participating in the UFCC. These funds are distributed through a volunteer-led grant process. The Creating Healthier Communities of Florida Agencies and the Independent Community Agencies will receive their designated and their percent of undesignated dollars.
